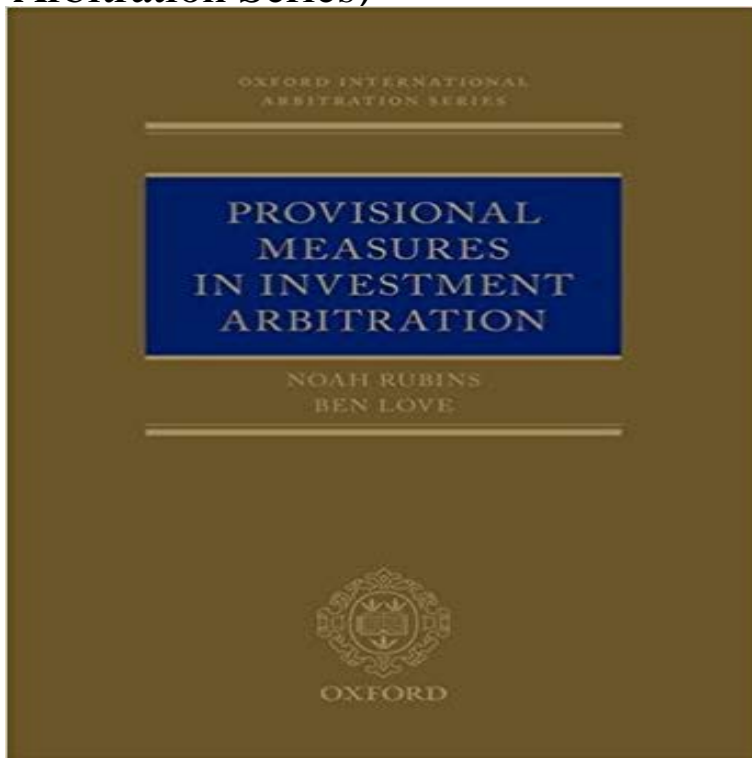


Provisional Measures in Investment Arbitration (Oxford International Arbitration Series)



Provisional measures are an increasingly important mechanism for investment protection in investment arbitration. There is a critical mass of jurisprudence as well as numerous cases that have exhibited novel uses for provisional measures, calling for a thorough examination.
