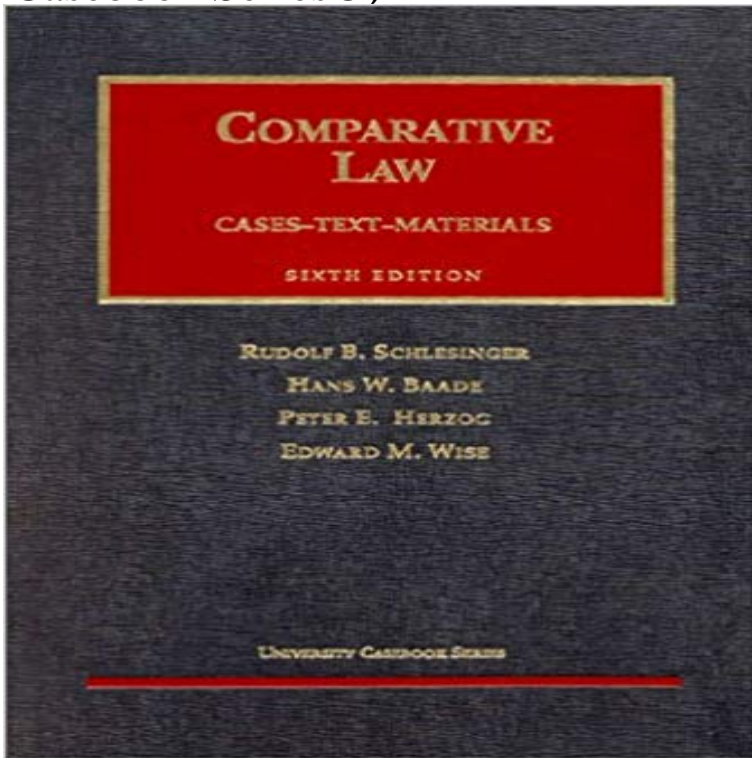


Schlesinger, Baade, Herzog and Wise's Comparative Law, 6th (University Casebook Series®)

It traces the continuing impact that both European Community law and regional human rights law have had on the internal legal systems of European countries, concomitant tensions toward a revised common law of Europe, and toward a closer convergence between civil and common law systems. It discusses renewed attention to the methodological problems faced by comparative law, in part because of these other problems.
